## **New Alberta Restrictions**

### **Tenant Bulletin: Please pass onto all Staff**

As most are aware, the Government of Alberta announced several new restrictions for the province yesterday. We wanted to provide some additional information on how these restrictions will and will not impact services at Jamieson Place.

The building will remain open during business hours (Monday to Friday, 6 a.m. to 6 p.m.) as it has been with only one dedicated entrance located in the SW corner of the main floor.

The +15 entrance remains open at this time, however, there is the potential that these will be closed in the coming weeks. A separate communication will be issued with any new information.

The bike cage and P1 changerooms will remain open with strict adherence to maximum occupancy as posted.

There will be no change to Shipping/Receiving services, with all incoming and outgoing deliveries available through the Shipping/Receiving office.

The Fitness Centre will remain closed, however, LIVNorth has numerous virtual offerings which we encourage all members to use:

The Government of Alberta's new restrictions include mandatory working from home unless the employer requires a physical presence for operational effectiveness. Mask use is also mandatory in all indoor workplaces, except when working alone in an office or a safely distanced cubicle or a barrier in place.

Our Building Operations and Janitorial teams will be periodically running water in all sinks and toilets to prevent stagnant water, knowing that these fixtures will not be used regularly. If for some reason you would prefer us not to do so, please communicate this via QuadReal Connect.

The Province announced yesterday that the Small and Medium Enterprise Relaunch Grant has been increased from \$5,000 to \$20,000 and is retro-active to March 2020. The threshold for qualifying for the program has also been reduced from 40% revenue loss to 30% revenue loss.

Businesses can use these funds as they see fit to help offset a portion of their relaunch costs, such as implanting measures to minimize the risk of virus transmission, which could include physical barriers, purchasing personal PPE and disinfecting supplies, paying rent and employee wages, replacing inventory, and more.
